Operating an Environmental Management System to manage our energy and environmental impacts accredited to ISO 14001.

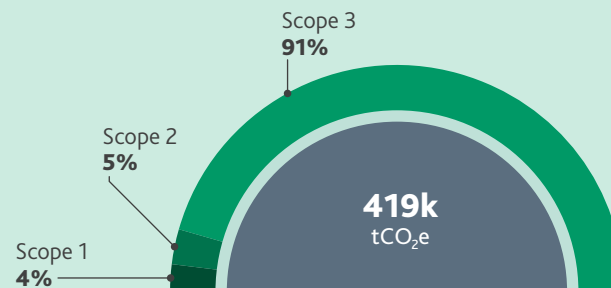
